1. Medication Overview: What Is Percodet?

Attribute	Details
Generic name	Oxycodone/acetaminophen (often abbreviated Oxy/Ac)
Brand names	Percocet®, Roxicodone® + Acetaminophen, generic “oxycodone-acetaminophen”
Composition	Each tablet typically contains 5 mg, 7.5 mg, or 10 mg of oxycodone combined with 325 mg of acetaminophen. Some extended-release formulations exist, but the immediate-release tablet is the most common prescription.

Therapeutic purpose	Short-term management of moderate to severe acute pain (e.g., post-operative pain, traumatic injury, dental procedures). It is not intended for chronic non-cancer pain, routine headaches, or “just to feel good.”

Why the combination? The acetaminophen component allows for lower opioid doses while still achieving adequate pain relief, potentially reducing the risk of opioid-related adverse events. However, the acetaminophen ceiling (generally 4 g/day) introduces its own safety considerations, especially concerning liver toxicity.

2. Approved Medical Uses

Percodet is FDA-approved for the following indications:

- Acute postoperative pain – after surgeries such as orthopedic, abdominal, or dental procedures.
- Acute musculoskeletal injuries – fractures, severe sprains, or contusions that produce significant pain.
- Severe breakthrough pain in cancer patients – when baseline analgesia is insufficient.

What it is *not* approved for

- Management of chronic non-cancer pain (e.g., chronic low-back pain).
- Treatment of anxiety, depression, or insomnia.
- “Recreational” use or as a “sleep aid.”

The distinction matters because prescribing guidelines (CDC, FDA) stress that opioids like oxycodone should be used only when the expected benefits outweigh the known risks and for the shortest duration necessary.

3. Dosage Guidance & Administration

3.1 Standard Adult Dosing (Immediate-Release Tablets)

Mild-moderate	5 mg oxycodone/325 mg acetaminophen	40 mg oxycodone (≈ 4 tablets of 10 mg)	Every 4–6 h as needed

Moderate-severe	7.5 mg or 10 mg oxycodone/325 mg acetaminophen	Same as above	Every 4–6 h as needed
Maximum acetaminophen	—	3 g (to stay under 4 g limit)	—

* *Maximum daily opioid dose is a guideline; clinicians may prescribe less based on patient age, liver function, renal function, and concomitant medications.*

Key administration points

- Take with food or a full glass of water to minimize stomach upset.
- Do not exceed the prescribed amount of acetaminophen; combining with other acetaminophen-containing products (e.g., cold medicines) can quickly surpass safe limits.
- Avoid alcohol while on Percodet – it increases sedation and liver toxicity risk.

3.2 Special Populations

Population	Adjustments
Elderly (≥65 y)	Start at the lowest dose (5 mg) and increase slowly; monitor for confusion or falls.
Renal or hepatic impairment	Dose reduction or alternative analgesics are often preferred.
Pregnant or breastfeeding	Generally contraindicated; discuss alternatives with your provider.

4. Risks, Side Effects, and Dependency Concerns

4.1 Common Side Effects ($\geq 1\%$ incidence)

- Drowsiness, dizziness, or light-headedness
- Nausea, vomiting, constipation
- Dry mouth, sweating
- Mood changes (euphoria or dysphoria)

4.2 Serious Adverse Events (Rare but Critical)

- Respiratory depression – especially when combined with benzodiazepines, sedatives, or high doses.
- Severe liver injury – if acetaminophen exceeds 4 g/day or if the patient has pre-existing liver disease.

Signs of problem use

- Taking the medication more often than prescribed
- Seeking early refills
- Using other substances (alcohol, benzodiazepines) concurrently
- Experiencing withdrawal symptoms (e.g., anxiety, tremors) when doses are missed

6. Frequently Asked Questions (FAQ)

Q1. Can I legally purchase Percocet online without seeing a doctor?

A: No. Percocet is a Schedule II controlled substance. Federal law requires a written prescription from a licensed prescriber after a bona-fide medical evaluation. Any site promising “no prescription” is operating outside the law.
